CARE AND MAINTENANCE

Your Viking Sink marble top requires **MINIMAL** care to maintain its beauty. The surface is nonporous which resists staining. Routine cleaning with a damp cloth or sponge using a <u>NON-ABRASIVE</u> general purpose or foam cleaner is normally all that is needed. Harsh abrasive cleansers, lye solutions, bleaches, peroxides and chemical solvents are neither required nor recommended.

To maintain luster and make cleaning easier, periodic applications of paste wax or products designed for CULTURED MARBLE may be applied.

Minor abrasions and scratches may be removed by using a very mild automotive polishing compound or baking soda.

Deeper scratches and more extensive damages may require on-site repair by a qualified dealer representative.

Excessive hot water may crack sink around the drain.

INSTALLATION

INSPECTION

Visually inspect for damage that may have been caused in transit. **DO NOT** install a damaged top.

SIZING

Trial fit vanity top to cabinet and walls. If necessary trim or shave cabinet top with a belt sander to assure top fits flat on the cabinet base. If sink fits to wall on one end and that wall corner is out of square, you may belt sand the end of the vanity top that fits to the wall. Care must be taken not to chip or remove too much material from the sink end when doing this procedure.

INSTALLING FAUCET AND DRAIN

Install faucet and drain according to manufacturers directions. Use a high quality silicone caulk under the drain collar. <u>DO NOT USED PLUMBERS PUTTY</u>; <u>DO NOT OVERTIGHTEN DRAIN!!</u> Normally 1/8 to 1/4 turn past hand tight is sufficient. Remove excess silicone with denatured alcohol.

INSTALLING THE VANITY TOP

Remove dust from top of cabinet and bottom of vanity top with denatured alcohol. Apply silicone to top corners of base cabinet. Carefully place vanity top onto cabinet base. Side splash should be installed last after all plumbing connections are made.

CAULKING

Clean entire top with a mild household cleaner, and dry thoroughly. Apply thin bead of silicone caulk to seal joint next to wall and top of backsplash. Wipe off excess with denatured alcohol.

LIMITED WARRANTY

Viking Sink Company expressly warrants that its manufactured sink products are free of defects in material and workmanship on the date of delivery, subject to the limitations set forth in this Limited Warranty. This does not cover: damage after manufacturer's delivery, use of excessively hot water – **Over 140° F will void warrenty** (120° F is recommended), cracks, chips, or scratches (unless caused by material or workmanship), minor surface imperfections, warpage and color or filler shade variations. Failure of any adhesive, caulk, or other accessory, or failure of any joint or seam, are not included in this Limited Warranty. This Limited Warranty covers the product for normal interior use in the United States, Mexico and Canada and does not cover the product moved from its original place of installation. Labor charges incurred during any installations are not included under this Limited Warranty.

Viking Sink Company will, at its option, repair, replace, or make suitable adjustment if a Viking Sink Company product fails due to a Viking Sink Company manufacturing defect, which is discovered during the limited warranty period.

This Limited Warranty applies to Viking Sink Company products that are maintained as described in the Care and Maintenance Guide and installed as described in the Installation Guide; installation constitutes acceptance. For service under this Limited Warranty, you must notify the dealer from whom you purchased the product or Viking Sink Company in writing, providing your name and address, a description of the product involved, the nature of the defect or failure, and proof of purchase and date of purchase. This Limited Warranty does not include labor charges needed to repair or replace the defective product nor does it include the labor to remove, repair or replacement of fixtures, hardware or decorative treatments.
